MOSA requires three years of field history information for all land that is newly requested for certification. In addition to the Crop Summary/Current Year Field Plan form, for any new land requested for certification, submit a Prior Land Use Declaration (PLUD) form if land was under someone else’s management during the past 36 months or a 3 Year Field History form if the land has been under your management.
