



## SEED TABLE

### National Organic Program Production Requirements

- Edible Sprouts (for human or organic livestock consumption): Without exception, all sprout seed must be certified organic;
- Annual Seedlings (transplants): Unless a temporary variance has been granted by the National Organic Program, all annual seedlings must be certified organic;
- Seed (crops, cover crops, plowdowns, and microgreens): Seed must be organic if commercially available. Before nonorganic seed may be used, an organic search must be performed. Nonorganic seed must be untreated and non-GMO;
- Planting Stock (annual and perennial): Before nonorganic planting stock may be used, an organic search must be performed. All nonorganic planting stock must be untreated post-harvest for the immediate harvest of an organic crop, and must be managed organically for a minimum of 12 months before the planting stock itself may be sold as organic;
- Treatments: All seed treatments and inoculants must be reviewed by MOSA for compliance with the National Organic Standards and approved before use;
- Phytosanitary Regulations: Seeds, annual seedlings, or planting stock treated with prohibited substances required for compliance with Federal or State phytosanitary regulations may be used in organic production. Documentation of the phytosanitary requirements is required.

**Instructions** - Use this form to document all seed, annual seedlings (grown or purchased), or planting stock used or planned for use in the current year. If you are an initial applicant or an updating client with new land, all seed, seedlings, or planting stock used within the past 36 months should also be listed. Prior years' seed, seedlings, or planting stock should correspond with the crop listings on your 3 Year Field History forms. For existing stands of alfalfa planted after January of 2011, provide non-GMO documentation of seed planted. Vegetable producers may compile this information in an alternative, easily auditable format, provided that all information requested on the Seed Table is included.

**Inspection Preparation** - Have a completed Seed Table, all receipts, at least one tag/bag for each variety of seed or planting stock listed, and an organic certificate for all annual seedlings available at your annual inspection. If nonorganic seed or planting stock is purchased, a completed Organic Search form (see form for instructions) and the catalogs you consulted (as applicable), untreated documentation, and non-GMO verification for crops with GMO potential will also be verified by your inspector.
